***Alarm Verification** - means an attempt to verify the validity of the alarm signal must be made prior to a dispatch request being made.

ECV (Enhanced Call Verification) requires the Two-Call protocol.

***Suspension** - Police response to an alarm site is suspended after "X" false alarms or non-payment, etc.

***Broadcast & File** - a policy of Broadcasting the alarm information to patrol units, but will be responded to at the discretion of the patrol officer. No response is promised.

***VR - Verified Response** - requires an eye witness to confirm that there was a break-in before police will respond.
They will not respond to alarm signals.

***ECV** - Enhanced Call Verification requires two telephone calls to attempt to verify an alarm prior to dispatch.

***2 Alarms Required** - two alarms are required for dispatch. In Auburn, this requirement applies to all commercial alarms, but only to motion detectors in residential systems. The police will respond to a single alarm in a home except from a motion detector.
